

THE ALTERNATIVE PUNTERS SYNDICATE

Terms & Conditions of Membership

1. The Alternative Punters Syndicate (TAPS for short) is operated by Racing and Leisure Limited.
2. The services provided to TAPS Private Syndicate and/or TAPS Laying Service members are as follows:
 - a) An Operations Manual providing detailed advice on how to make the most of the syndicate's betting information and the syndicate's marketing opportunity.
 - b) A daily horse racing betting advisory service supplied via a non-premium rate telephone line and email.
 - c) A daily sports betting advisory service supplied via a non-premium rate telephone line and email. (TAPS Private Syndicate members only).
 - d) A weekly football fixed odds and pools betting advisory service supplied by a non-premium rate telephone line and email. (TAPS Private Syndicate members only).
 - e) An optional marketing opportunity.
3. Racing and Leisure Limited reserves the right to make alterations to any of the services provided and/or operational procedures as deemed necessary.
4. Owing to the nature of the information supplied refunds are not made under any circumstances including for part used subscriptions.
5. Membership is renewable on the agreed terms and your subscription payment will be taken as your express wish to renew your membership for your chosen period.
6. You have the right to cancel your membership at any time by giving written notice to the syndicate administrator no later than 24 hours before your subscription payment is due.
7. If you decide to cancel your membership, it is your responsibility to cancel your standing order with your bank, PayPal or any other payment method before it is next due.
8. If you fail to comply with both instructions as in 6 and 7 above, any money paid by your bank, PayPal or any other payment method will not be refunded, as it will be deemed that paragraph 5 was then applicable.
9. Members are advised not to bet with money they cannot comfortably afford to lose. Racing and Leisure Limited will not be held responsible for money staked/lost by the member or for debts/liabilities incurred by the member. The same applies to any money deposited with the syndicate administrator or his agents for betting purposes on any of the services provided.
10. The member must notify the syndicate administrator, in writing, of any change of postal and/or email address otherwise no responsibility will be accepted for non-delivery of mail and/or information.
11. All betting information is for the member's use only and must not be passed to any third party.
12. The Operations Manual remains the property of Racing and Leisure Limited and no part of it may be reproduced without written permission from the syndicate administrator.
13. The advice contained in the Operations Manual is intended to help the member profit from both the betting information provided and also the optional marketing opportunity. However no responsibility is accepted by Racing and Leisure Limited or its agents for any loss whatsoever caused by errors or omissions whether negligent or otherwise.
14. Members who want to promote the syndicate via the optional marketing opportunity must first complete an agreement form. This is to comply with current legislation but places the member under no obligation whatsoever.
15. Subscription fees are guaranteed never to increase for members who keep their membership active.
16. All UK members must be over 18 years of age. Non-UK residents accept it is their sole responsibility to comply with all their Country's relevant laws.
